## **SYNOPSIS**

#### Title of the project:

"A Study on Legal Compliances in Industrial Units of Nalbari Industrial Estate"

#### **Introduction and Objectives:**

There is often a lack of enforcement and monitoring of labour laws by regulatory authorities. Weak governance can hinder the effective implementation of labour regulations, allowing employers to continue exploiting workers' rights without facing any consequences. Moreover, the lack of awareness and knowledge among the workers regarding their legal rights leaves them vulnerable to exploitation and makes it challenging for them to hold their employers accountable for non-compliance.

The challenges relating to legal aspects, "Nalbari Industrial Estate," located in the state of Assam, is no exception. This study aims to explore the challenges faced by industrial labour in terms of legal compliance in Nalbari Industrial Estate, such as unsafe working conditions, unfair wages, workers' safety, and how low compliance with legal rights affects their overall well-being.

#### **Objectives of the Study:**

The study is conducted:

- 1. To analyze the legislation passed by the government of India to control the affairs of the Indian business houses
- To make an overview of the special legal provisions of the Companies Act, 2013
